HOW IT WORKS

In partnership with the Child Support Lien Network (CSLN), hosted by the State of Rhode Island, we are proud to announce the introduction of our Lump Sum Payment Module. As a CSLN member, Stellarware will utilize your agency's existing CSLN obligor file [or another State-provided child support case file], loading it into our Lump Sum Database for employers across the State to conduct data matching via our secure portal, using an Interactive Lookup or Batch upload process. Agencies are immediately notified whenever matches are made while the appropriate documents to employers [income payers] are electronically generated for collection purposes.
